All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, in a subdivision known as Medical Court, being known and designated as Lot No. 1 of said subdivision and being described according to a plat prepared by the Piedmont Engineering Service, Greenville, S. BEGINNING at a point in the center of a 20-foot street at its intersection with Pendleton Street, said point being 160 feet East of Leach Street, and running thence along the Southern side of Pendleton Street S. 71-27 E. 80 feet to an iron pin; thence S. 18-24 W. 102 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence along the common line of Lots Nos. 1 and 2 N. 71-27 W. 80 feet to a point in the center of said 20-foot street; thence along the center of said 20-foot street N. 18-24 E. 102 feet to the beginning corner.

This property is conveyed subject to, and with the benefit of, easements and restrictions established for the mutual benefit of all the property in Medical Court subdivision, as shown on plat of said subdivision, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book W, at page 77, including:

- (1) The easement or right-of-way for a street 20 feet wide, running through the center of the subdivision from Pendleton Street to Arlington Avenue, the center of which street is the front line of the lot herein conveyed, which street shall forever remain open for the benefit of all the abutting property.
