"All that certain piece, parcel or lot of land in Ward I in the City of Geeenville, State of South Carolina, being situate on the East side of Rutherford Street and shown on plat by W. D. Neves, January, 1941, as revised by Dalton & Neves, Engineers, October, 1949, and having the following metes and bounds:

BEGINNING at a stake on the East side of Rutherford Street, which stake is on the new right-of-way line of Rutherford Street and is 69.4 feet North of the Northeast corner of a 12-foot alley and Rutherford Street and running thence S. 88-26 E. 96.8 feet to a stake; thence N. 1-34 E. 20 feet to a stake; thence S. 89-19 E. 42.3 feet to an iron pin; thence N. 1-34 E. 49.5 feet to an iron pin; thence N. 87-18 W. 138.2 feet to a stake on the new right-of-way line along Rutherford Street; thence with said Street S. 1-52 W. 75.7 feet to the beginning."
