M. C. Office for Greenville County, S. C. in Plat Book "K", Page 53, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Bennett Street at the joint corner of Lot #7 and property of Burgess, and running thence with Burgess' line, N. 89-30 W. 400 feet to an iron pin on the Eastern side of Westview Avenue at the corner of Lot #8; thence along the Eastern side of Westview Avenue, S. 4-0 W. 225 feet to an iron pin, joint front corner of Lots 10 and 11; thence with the joint line of Lots 10 and 11, S. 89-30 E. 175 feet to an iron pin, joint corner of Lots 10, 11, 4 and 5; thence with the joint line of Lots 5 and 10, N. 4-0 E. 75 feet to an iron pin, joint corner of Lots 5, 6, 9 and 10; thence with the joint line of Lots 6 and 9, N. 4-0 E. 13.32 feet to a point; thence a new line through Lot #6, N. 89-0 E. 193.23 feet more or less to a point in the front line of Lot #6 and on the Western side of Bennett Street, which point is also 13.32 feet in a Northerly direction from the joint front corner of Lots 5 and 6; thence along the Western side of Bennett Street, N. 16-0 E. 61.68 feet to an iron pin, joint front corner of Lots 6 and 7; thence still with the Western side of Bennett Street, N. 16-45 E. 76 feet to the beginning corner; reserving, however, to the Grantor, her heirs and assigns, an easement for sewer purposes only over a strip five feet wide and 175 feet in length, which strip is along the Southern boundary of Lot #10 above.
