Know All Men by These Presents:

That I, Mrs. Geanie L. Caldwell in the State aforesaid, in consideration of the sum of Three Hundred Thirty-five (\$335.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John T. Wilson and his heirs and assigns:

All of that parcel or lot of land situate and being in Chick Springs Township of Greenville County, South Carolina, lying North from the City of Greer and the New U.S. Dual Lane Highway No. 29, being all of lot No. 59 on a plat of property made for Mrs. Geanie L. Caldwell by H.L. Dunahoo, Surveyor, dated October 24-25, 1949, recorded in the R.M.C. Office for Greenville County in Plat Book X, at page 1. Said lot lies 286 feet North from the right-of-way of said U.S. Highway and lies on the East side of Caldwell Street, fronting thereon 122 feet, and has such shapes, corners, lines and courses as appears by reference to said plat and record thereof, the description on said plat being incorporated herein and made a part of this deed.

This property is to be used only for residential purposes with desirable appurtenances thereto, for White people only, and specifically prohibited are trailer camps, tourist courts, clubs, dance halls and so-called "honky-tonks" or "juke-joints", and the sales of beer, wine and alcoholic liquors. No dwelling house shall be erected for a cost of less than \$3500.00, and the same must be placed at least 20 feet from the street on which it faces. These restrictions are for the benefit of the grantor and all owners of property in this subdivision, and any violation thereof shall entitle any owner of the same to injunctive relief. However, the rights of lien creditors shall not be impaired by any violations of these restrictions.

The above is a part of that property conveyed to me by Charlie Littlefield, et al, by deed that is recorded in the R.M.C. Office for Greenville County in Deed Book 129, at page 596.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
