

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of Lanneau Drive in that area recently annexed to the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 61 on Plat of Lanneau Drive Highlands, made by Dalton & Neves, Engineers, August 1937, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "D" pages 288 and 289, and having, according to said plat and a recent survey made by R. W. BEGINNING at an iron pin on the West side of Lanneau Drive at joint front corner of Lots 61 and 62 said pin being 380.3 feet in a Southeasterly direction from the Southeast corner of the intersection of Lanneau Drive and McPherson Street, and running thence with the line of Lot 62 N 79-49 W 150 feet to an iron pin; thence S 10-11 W 50 feet to an iron pin; thence with the line of Lot 60 S 79-49 E 150 feet to an iron pin on the West side of Lanneau Drive; thence with the West side of Lanneau Drive N 10-11 E 50 feet to the beginning corner.

As part of the consideration herein, the Grantee assumes and agrees to pay that mortgagor given by A. Roy Ashley to the Liberty Life Insurance Company in the original sum of \$10,400.00, November 29, 1949, recorded in the R.M.C. Office for Greenville County, S. 
