

BEGINNING at an iron pin on the Western side of Springside Street, joint corner of Lots Nos. 59 and 60; thence with the line of Lot No. 59, S. 73-45 W. 105.1 feet to an iron pin; thence N. 16-15 W. 66 feet to an iron pin; thence N. 73-45 E. 105 feet, more or less, to an iron pin on the Western side of Springside Street; thence with Springside Street, S. 16-50 E. 66 feet to the beginning corner.
