Stewart and his heirs and assigns: All of those parcels or lots of land situate and being in Chick Springs Township of Greenville County, South Carolina, lying North from the City of Greer and the U.S. Dual Lane Highway No. 29 and on the West side of Caldwell Street, being all of lots Nos. 18,19 and 50 on a plat of property made for Mrs. Geanie Caldwell by H.L. Dunahoo, Surveyor, dated October 24-25, 1949, recorded in the R.M.C. Office for Greenville County in Plat Book X, at page 1. Said lots lie on the West side of Caldwell Street and have a combined frontage thereon of 210 feet, having a rear width of 210 feet and an uniform depth of 173 feet. Reference to said plat and record thereof is made for a detailed and complete description of said lots.

This property is to be used only for residential purposes with desirable appurtenances thereto, for White people only, and specifically prohibited are trailer courts, tourist courts, clubs, dance halls and the sales of beer, wine and alcoholic liquors. No dwelling house shall be erected for a cost of less than \$3500.00, and it must be placed at least 20 feet from the street on which it faces. These restrictions are for the benefit of the grantor and all owners of property in this subdivision, and any violation thereof shall entitle any owner of same to injunctive relief. However, the rights of lien creditors shall not be impaired by any violations of these restrictions.
