

in the State aforesaid, Robert D. Bates That in consideration of the sum of Twelve Hundred Fifty and No/100----(\$1250.00)------DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. K. Puckett, Jr., his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the North side of Old Spartanburg Road (sometimes referred to as East North Street Extension) in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot 55, Block E, on Plat of Property of Corrine Bates, made by Pickell & Pickell, Engineers, May 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", page 57, and having, according to said plat, the following metes and bounds,

BEGINNING at an iron pin on the North side of Old Spartanburg Road at joint front corner of Lots 55 and 54 of Block E, said pin being 100 feet East from the Northeast corner of intersection of Old Spartanburg Road and a 40 foot unnamed street, and running thence with the line of lot 54 N 28-30 W 200 feet to an iron pin; thence N 56-37 E 100 feet to an iron pin; thence with the line of lot 56 S 28-30 E 200 feet to an iron pin on the North side of Old Spartanburg Road; thence along the North side of Old Spartanburg Road S 56-37 W 100 feet to the beginning corner. The 40-foot unnamed street mentioned above is now known as Corinne Drive.

This is one of the lots conveyed to me by deed of Corrine Bates, individually and as Trustee, dated May 7, 1948, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 246, at page 105.

Grantee to pay 1950 taxes. This property is conveyed subject to the following restrictions:

This property shall be used for residential purposes only.

No residence shall be constructed on said lot costing less than \$7500.00

The said lot shall not be sub-divided or re-cut.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
