

Know All Men by These Presents:

That I, Mrs. Geanie L. Caldwell, in consideration of the sum of Five Hundred Seventy-five (\$575.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John M. Caldwell and Martha G. Caldwell and their heirs and assigns: All of those parcels or lots of land situate and being in Chick Springs Township of Greenville County, South Carolina, lying North from the City of Greer and the U.S. Dual Lane Highway No. 29, and also lying on the East side of Caldwell Street and the South side of Highland Drive, being all of lots Nos. 55 and 56 on a plat of property made for Mrs. Geanie Caldwell by H.L. Dunahoo, Surveyor, dated October 24-25, 1949, recorded in the R.M.C. Office for Greenville County in Plat Book X, at page 1, having the following courses and distances: BEGINNING on a stake at the intersection of Highland Drive and Caldwell Street, and runs thence with the eastern edge of Caldwell Street S. 11.30 E. 215 feet to a stake, joint front corner of lots Nos. 56 and 57; thence with the common line of these two lots N. 78 E. 268 feet to a stone on South side of Highland Drive; thence with the southern edge of Highland Drive N. 62.30 W. 334 feet to the beginning corner.

This property is to be used only for residential purposes with desirable appurtenances thereto, for White people only, and specifically prohibited are trailer courts, tourist courts, clubs, dance halls and so-called "honkytonks" or "juke-joints", and the sales of beer, wine and alcoholic liquors. No dwelling house shall be erected for a cost of less than \$3500.00, and the same must be placed at least 20 feet from the street on which it faces. These restrictions are for the benefit of the grantor and all owners of the property of this subdivision, and any violation thereof shall entitle any owner of the same to injunctive relief. However, the rights of lien creditors shall not be impaired by any violations of these restrictions.
