

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto $J \cdot A \cdot Dusenberry$ and Isabel M.Dusenberry, their heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the Southern side of woodland way in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lots 4, 5, 6 and 7, on Plat of the Estate of W. C. Cleveland, deceased, made by Dalton & Neves, Engineers, December, 1947, recorded in the R. M. C. Office for Greenville County, in Plat Book "S", page 33, and, having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of woodland Way at joint front corner of Lots 3 and 4, said pin being 335 feet East from the Southeast corner of the intersection of WoodlandWay and Southland Avenue and running thence along the line of Lot 3 S 29-06 E 286.4 feet to an iron pin on the North side of a 25 foot drive; thence along the North side of said drive, N 63-24 E 435.3 feet to an iron pin in line of Lot 8, now property of Annie Newby Riddle; thence along the line of Lot 8 N 35-46 W 302.5 feet to an iron pin on the South side of woodland way; thence along the South side of Woodland way S 60-54 W 400 feet to the beginning corner.

This property is conveyed subject to the following building restrictions:

- 1. This property shall be used for residential purposes only.
- 2. No dwelling shall be built on said lot costing less than \$10,000.00.
- 3. No building shall be constructed on said lot nearer than 75 feet to Woodland Way.
- 4. No commercial dog kennel shall be constructed on the above described property.
- 5. No horse barn or stables shall be constructed on the above described property.
