at corner of lot heretofore conveyed by Josephine B. Norwood to Marguerite T. Sease; thence along said Sease line N 25-0 E 64 feet to an iron pin; thence S 61-0 E 126.1 feet, more or less, to an iron pin on the West side of Butler Avenue; thence along the West side of Butler Avenue in a Southerly direction 57 feet 10 inches to the be-
