All those certain pieces, parcels, or lots of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina on the Western side of Druid Street in a subdivision known as Stone Estates, Unit No. 2, being known and designated as Lots Nos. 6, 7 and 8, Block B, of said subdivision, said property being described according to a plat of Stone Estates, Unit No. 2 prepared by C. M. Furman, Jr., Civil Engineer, dated December, 1931, and having, according to the aforementioned plat, the following metes and bounds, to-wit:
