

Bruce, Furman C. Smith and Others, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "T", at Page 173, and having, according to said plat, the following metes and bounds, to wit:

EEGINNING at an iron pin on the Easterly side of Taber Street, joint front corner of Lots #1 and #2, Property of James M. Bruce, Furman C.
