Allen, his heirs and assigns, all that piece, parcel or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lots Nos. 68, on plat of University Park by Dalton & Neves, dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:


BEGINNING at an iron pin on the northern side of Bradley Boulevard at joint front corner of Lot Nos. 69 and 68 and running thence with joint line of said lots N. 39-58 W 361.4 feet to an iron pin on branch; thence with branch as the line, the traverse course of which is N. 20-56 E., 129 feet to an iron pin, joint corner of Bradley Estates and lot No. 68; thence with joint line of said property S. 37-34 E 430.2 feet to an iron pin on the northern side of Bradley Boulevard; thence with Bradley Boulevard S 52-26 W. 95.6 feet to the beginning corner.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
