

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the South side of East Earle Street, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 35 and a portion of Lot 34 on Plat of Mountain City Land and Improvement Company, made by J. N. Southern, Surveyor, February 20, 1891, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book VV, page 543-544 (see also plat recorded in Plat Book "C", page 171) and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of East. Earle Street said pin being 54.6" East from the intersection of East Earle Street and Elizabeth Street also corner of lot now or formerly T. M. Wells; thence along said Wells line S. 18-30 W. 206'6" to iron pin; thence S. 71-20 E. 71'9" to iron pin at corner of lot now or formerly Stuckey; thence with the Stuckey line N. 18-30 E. 206'6" to iron pin on the South side of East Earle Street; thence along the South side of East Earle Street N. 71-20 W. 71'9" to the beginning corner.
