All that certain piece, parcel or triangular lot of land situate, lying and being on the south side of Tindal Avenue in the city of Greenville, state of South Carolina, county of Greenville, and being a small portion of lot No. A as shown on plat recorded in plat book I page 48 of the R. M. C. Office for Greenville County, and being more particularly described according to a recent survey made by Piedmont Engineering Service August 5, 1950 as follows:

Beginning at a point on the south side of Tindal Avenue, which point is the front western corner of said lot, and the joint corner of property of the grantor and grantee; and running thence with the line of the property of the grantee S. 5-00 W. 73.6 feet to a point in the joint line between the property of the grantor and grantee; thence N. 1-50 W. 73.5 feet to a point on the south side of Tindal Avenue; thence with the south side of said Avenue S. 89-32 W. 2.7 feet to the point of beginning.

This triangular strip of land is conveyed to the grantee in exchange for a triangular strip of the grantees lot at the rear, and is made for the purpose of straightening the boundary line between the grantor and grantee.
