Ewing, herein called grantee, all that lot in the southwest intersection of Long Hill Street and Henrietta Avenue which is shown as the northern portion of Lot 87 as delineated on plat of Augusta Road Ranches which is recorded in Plat Book M at Page 47; the portion herein having been surveyed by Pickell & Pickell, June 27, 1947, which plat is recorded in Book R at Page 55. The lot is also shown on County Tax Map, District 8-G, Map 212, Block 7, Lot 17 and the northern portion thereof. From the above plats the following description is taken:

BEGINNING at an I.P. which is the southwest intersection of Long Hill St. and Henrietta Ave., and running thence S. 83-18 W. 35.5' to an I.P. on Henrietta Ave., thence the south side of said Avenue S. 38-18 W. 11.6' to an I.P. which is the joint corner between the original Lots 86 and 87; thence running the joint line between these lots S. 8-53 E. 143.5! to an I.P. which constitutes the joint rear corner between parcels A and B into which the Pickell plat divides Lot 87; thence running the joint line between these parcels N. 74-29 E. 143.3' to an I.P. on Long Hill St.; thence running the western edge of that street N. 29-39 W. 49' to an I.P.; thence N. 51-42 W. 119.8' to the beginning
