All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 8-FE, and being known and designated as all of Lot No. 7 and a portion of Lot No. 6 of a subdivision of the property of T. T. Norris, as shown on plat thereof made by G. A. Ellis, Surveyor, on February 21, 1940 and recorded in the R. M. C. office for Greenville County in Plat Book I, at page 148, and having, according to a survey made on August 10, 1950 by the Piedmont Engineering Service, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Bradley street at the corner of Lot No. 8, which point is 215 feet North of the intersection of White Circle Road, and running thence along the line of Lot No. 8, N. 63-46 E. 157 feet, more or less, to an iron pin at the rear corner of Lot No. 4; thence along the line of Lot No. 4, N. 23-00 W. 72.6 feet to an iron pin at a point 5 feet North of the rear corner of Lot No. 4; thence on a line parallel with the line of Lot No. 7, and 5 feet distance therefrom, S. 64-46 W. 160 feet, more or less, to an iron pin on the East side of Bradley street, which pin is 5 feet North of the corner of Lots Nos. 6 and 7; thence along the East side of Bradley street, S. 25-30 E. 75 feet to the beginning corner.
