All of that parcel or lot of land situate and being in Chick Springs Township, in the County of Greenville, South Carolina, lying and being on the northwest side of the Dual Lane Highway (U. S. Highway No. 29), about one-half mile West from the Town of Taylors, being designated as Lot No. 7 on a plat of property made for W. S. Edwards by Pickell & Pickell, Engs., dated October 3, 1946, and having the following courses and distances:

Beginning on an iron pin on the northwest edge of right-of-way of said Dual Lane Highway, joint corner of Lots Nos. 6 and 7, and runs thence with the common line of Lots 6 and 7 N. 39.30 W. 209.7 feet to an iron pin on W. S. Edwards' line; thence with his line S. 50.30 E. 100 feet to an iron pin, corner with W. S. Edwards; thence with the Edwards line S. 39.30 E. 209.7 feet to an iron pin on the right-of-way of said highway; thence therewith S. 50.30 W. 100 feet to the beginning corner, and being the identical property this day conveyed to us by R.
