Jack Foster, his heirs and assigns, forever:

All of our right title and interest in and to that certain strip of land situate, lying and being on the Northeast side of Stone Avenue By-pass and on the Southwest side of what was formerly known as West Creek Street in the City of Greenville, County of Greenville, State of South Carolina and being the Northeastern most end of Lot 151 on Plat of Property of Fegan and Moseley which plat is recorded in Plat Book "A", at page 145 R.M.C. Office, Greenville County, S.C. and having the following metes and bounds, to-wit:

BEGINNING at a point on the Southwest side of what was formerly West Creek Street (as designated on the above plat) and running thence S.58-08 W. 8 feet more or less to the Eastern edge of the 50 foot right-of-way for Stone Avenue By-pass at corner of property heretofore conveyed to the City of Greenville; thence along the Eastern edge of said right-of-way S. 41-07 E. 36 feet to a point in the line of what was formerly West Creek Street; thence along said West Creek Street N. 39-18 E. 4 feet more or less to a point; thence along the West edge of West Creek Street N. 31-52 W. 34 feet more or less to point of beginning.

The above grantor, Montez L. Harris, by deed dated January 24, 1946, recorded in Deed Book 286, page 220, deeded to the City of Greenville the major portion of Lot 151 in order to effect a right-of-way for highway purposes. It was intended by said deed to convey all of the Northeastern portion of Lot 151. but through error in the description employed in said deed the small strip above described was inadvertently omitted and this deed is executed in order to vest in the present owner of property on the Northeast side of said Stone Avenue By-pass a good fee simple title. Mary C. Thomason by deed recorded in Deed Book 287. page 55 purchased the Western section of the remaining property of Montez L. Harris and joins in this deed in order to convey any interest that she may have acquired in and to the above parcel of land by virtue of said deed.
