That I, A. G. Howell, in the State aforesaid, in consideration of the sum of One Thousand Twenty-five (\$1025.00) DOLLARS, Lloyd G. Jones and Esther G. Jones to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lloyd G. Jones and Esther G. Jones, and their heirs and assigns:

All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, in the City of Greer, lying on the west side of a street that leads southward from a street that leads from West Poinsett Drive, sometimes known as Ford Street or Sherwood Street, being all of Lot No. 10 and a portion of Lot No. 9, on a plat of property made for Dr. J. T. Smith by H. S. Brockman, Surveyor, dated September 20, 1929, and having the following courses and distances

Beginning at an iron pin on the western margin of said Ford Street or Sherwood Street, joint corner of Lots Nos 10 and 11 on said plat, and runs thence with the common line of these two lots N. 77 W. 189 feet to an iron pin on the line of Lot No. 15; thence N. 13.30 E. 67.5 feet to a point, which point is of equal distant between the two iron pin corners at rear of Lot No. 9; thence a new line in an easterly direction 195 feet, more or less, to a stake on the western margin of said Ford or Sherwood Street; thence along the line of said street S. 17.20 W. 95 feet to the beginning corner.

The above is a part of that property conveyed to me by Dr. J. T. Smith by deed dated October 23, 1929, recorded in the R. M. C. Office for Greenville County, in Deed Book 127, at page 529.
