All those certain pieces, parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, School District 6-E, being known and designated as Lots Nos. 18 and 19 of the property of Talmer Cordell as shown on plat thereof prepared by Dalton & Neves, Engineers, March, 1950 and recorded in the R. M. C. office for Greenville County in Plat Book X, at page 179, and having, according to said plat, the following metes and bounds, to-wit:
BEGINNING at an iron pin on the East side of Welcome Street, joint front corner of Lots Nos. 19 and 20, and running thence along the East side of Welcome Street, S. 14-0 E. 60 feet to an iron pin at the joint front corner of Lots Nos. 18 and 19; thence continuing along the East side of Welcome Street, following the curvature thereof, S. 44-17 E. 50 feet to an iron pin in the front line of Lot No. 18; thence continuing along the East side of Welcome Street, still following the curvature thereof, S. 56-44 E. 54.8 feet to an iron pin; thence N. 48-37 E. 110 feet to the rear corner of Lot No. 18; thence along the rear lines of Lots Nos. 18 and 19, N. 14-0 W. 92.4 feet to the rear corner of Lot No. 20; thence along the line of that lot, S. 76-0 W 160 feet to the beginning corner; being a portion of the property conveyed to the grantor corporation by Jessie H. Mull, et al. by their deed dated March 29, 1950 and recorded in the R. M. C. office for Greenville County in Deed Vol. 405, at page 478.
