

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the raid C. E. ROBINSON, JR., E. M. LINEBERGER AND E. M. PAUL, JR.:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northern side of Wedgewood Avenue in a Subdivision known as Croftstone Acres, being known and designated as Lot No. 4, Block G, of said Subdivision and being described according to a plat of Croftstone Acres prepared by C. B. Dawsey, dated August, 1946, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book S, at Pages 78 and 79, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the Northern side of Wedgewood Avenue at the joint front corner of Lots Nos. 3 and 4, Block G, and running thence in a Northwesterly direction along the common line of said Lots, 174 feet to a point in the line of Lot No. 23, Block G; thence along the common line of Lots Nos. 4 and 23, Block G, in a Northeasterly direction 50 feet to a point, the joint rear corner of Lots Nos. 4 and 5, Block G; thence along the common line of said last mentioned Lots in a Southeasterly direction, 184.7 feet to a point on the Northern side of Wedgewood Avenue; thence along the Northern side of Wedgewood Avenue, S. 63-10 W. 90 feet to the beginning corner.
