

All that certain lot of land in Gantt Township, Greenville County, State of South Carolina, about six miles from Greenville Court House, on the White Horse Road near its intersection with the Augusta Road, being known and designated as Lot No. 8 on a plat of the property of Alma Eunice Jones made by W. J. Riddle, Surveyor, August 25th, 1942, and recorded in the R. M. C. Office for Greenville County in Plat Pook M, page 81, and having the following metes and bounds:

BEGINNING at a stake on the White Horse Road 233.5 feet from the intersection of the White Horse Road with the Augusta Road, at corner of Lot No. 7 on said plat, and running thence with line of Lots Nos. 7 and 6, N. 44-58 E. 267.7 feet to stake in Line of Lot No. 47; thence with line of Lot No. 47, N. 18-0 W. 61.3 feet to stake at corner of Lot No. 9; thence with line of Lot No. 9, S. 62-0 W. 273.2 feet to stake on the White Horse Road; and thence with the White Horse Road, S. 32-49 E. 74.3 feet to bend, and S. 37-46 E. 66.4 feet to the beginning corner.

The above described lot of land is a portion of the same conveyd to me by Alma Eunice Jones by deed dated October 29, 1946, and recorded in the R. M. C. Office for Greenville County in Book 301, page 343.

This conveyance is made subject to the condition that the above described lot of land shall be used exclusively for residential purposes, and that no factory store, shop, garage, or other commercial structure of any kind, whether temporary or permanent, shall be erected thereon, nor shall any commertial business or service be conducted upon the premises.
