FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is STEWART-TAYLOR HARDWARE & SUPPLY CO.

THIRD: That the principal place of business is

FOUNTAIN INN, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to buy, sell and otherwise deal in, either at wholesale or retail, all types and classes of hardware, tools, machinery, lumber and builders' supplies, coal, office and household furniture, furnishings, supplies and equipment, and electrical and mechanical appliances; to own, buy, sell, trade, lease, mortgage and otherwise deal in real estate; to operate either at wholesale or retail a general hardware and supply business and to do any and all other things necessary and incidental to the carrying on of such business.
