to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John O. Carter and Margaret W. Carter, their heirs and assigns forever,

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, containing fifty-three and one-half (53-1/2) acres, more or less, and having the following metes and bounds, to-wit:

Beginning on a road near the Augusta Road, and running thence, N. 29 E. 1.53 chains to a stone by a Hickory; thence S. 69 E. 3.60 chains to a stone; thence N. 1 E., 21.35 chains to a stone on branch; thence down the meanderings to said Branch to a stone; thence S.41 W. 10.25 chains to a Dogwood and stone; thence S. 19-1/2 W. 15.36 chains to a stone on said road; thence along said road, S. 67-3/4 E. 25.75 chains to a stone by a Pine at the beginning corner.

Excepting and Excluding Therefrom that tract heretofore conveyed by me to Jack Lanier containing 13.53 acres, more particularly described in Deed recorded in the R. M. C. Office for Greenville County in Deed Book 300, Page 165, leaving approximately 39.97 acres conveyed by this deed.

Being the same property conveyed to the grantor herein by deed of J. W. Lunsford dated October 10, 1946 and recorded in the R. M. C. Office for Greenville County in Deed Book 305, at page 223.

As a part of the consideration for this conveyance, the grantee assumes and agrees to pay the unpaid balance on a mortgage covering the above described premises heretofore executed by J. W. Lunsford to W. R. Hale, as Trustee for \$2500 in August 22, 1946 recorded in the R.M.C.Office for Greenville County in Mtge. Book 350, at p. 140, said unpaid balance being \$1,000.00

The grantes agree: to pay all taxes for the year 1950. TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
