

metes and bounds, to-wit: BEGINNING at an iron pin on the Northeast side of Patton Road, at joint front corner of Lots 40 and 41, and running thence with the line of Lot 40, N 70-12 E 165 feet to an iron pin; thence S 6-42 W 164.9 feet to an iron pin on the North side of Orders Drive; thence along the North side of Orders Drive, N 82-04 W 66.4 feet to an iron pin; thence continuing with the curve of Orders Drive and Patton Road, (the chord being N 53-51 W 43.9 feet) to an iron pin on the Northeast side of Patton Road; thence along the Northeast side of Patton Road, N 25-38 W 79.6 feet to the beginning corner.
