


All that certain piece, parcel or lot of land situate, lying and being at the Northwest corner of the intersection of Prancer Avenue and Long Hill Street in that area recently annexed to the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 260 on Plat of Pleasant Valley made by Dalton & Neves, Engineers, April 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "P", page 92 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Prancer Avenue at joint front corner of Lots 260 and 261 and running thence with the line of Lot 261 N. 0-08 W. 160 feet to an iron pin; thence N. 89-52 E. 120 feet to an iron pin on the West side of Long Hill Street; thence along the West side of Long Hill Street S. 0-08 E. 39.3 feet to a point; thence continuing with the curve of Long Hill Street the following chord distances: (S. 10-17 W. 46.6 feet; S. 33-37 W. 47.6 feet; and S. 56-07 W. 47.6 feet) to a point on the North side of Prancer Avenue; thence along the North side of Prancer Avenue S. 78-37 W. 47.6 feet to the beginning corner.
