

Budove, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville, being known and designated as Lot Number One (No. 1), and a 5-foot strip of Lot Number Two (No. 2) of the property of John B. Marshall, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book "E" at page 39, and having the following metes and bounds, to-wit:
