

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to
be heard on the13th day ofFebruary1951,
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,
Master in and for the County aforesaid, toErnest E. Williams
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Preesents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree,
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Ernest E. Williams, all the right, title and interest of the Plaintiff and Defendants, in and to the following described real estate:
"All that lot of land on the South side of East Pinehurst Drive, in that area recently annexed to the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 11 and the adjoining 25 feet of Lot 12, on plat of property of Helen M. Powe, made by W. J. Riddle, June, 1944, recorded in the R. M. C. Office for Greenville County, S. C.; in Plat Book "P", at Page 65, and having, according to said plat, the following metes and bounds, to-wit:
BEGINNING at an t ron pin on the South side of East Pinehurst Drive, at joint corner of Lots 10 and 11, and running thence along the line of Lot 10, S. 1-15 W. 197 feet to an iron pin; thence S. 89-52 E. 86.6 feet to an iron pin in the rear line of Lot 12; there e through Lot 12, N. 1-15 E. 197 feet to an iron pin on the South side of East Pinehurst Drive in the front line of Lot 12; thence along the south side of East Pinehurst Drive, N. 89-52 W. 86.6 feet to the beginning corner." This lot being subject to the right-of-way for a water line as shown on the recorded plat referred to above.
The consideration for the above conveyance was the sum of \$595, which amount was paid to T. Lee Redfearn during his life time.
