Jenkins, John Henry Jenkins, Jr., and Joel Perritt Jenkins, their heirs and assigns, All my right title and interest in and to all that certain tract or parcel of land containing one acre, more or less, in Grove Township, Greenville County, South Carolina, having the following metes and bounds: BEGINNING at a stone on the Ellison and Rogers corner thence with Ellison line N. 41 CW 7.52 chs. to a stake; N. 49 E. 2.15 to a stake in road; thence with the road S. 37 E. 70 links to a stake in road; thence S. 31 E. 6.80 to a stake in Rogers line; thence with said line S. 42 W. 94 links to the beginning corner. This land adjoins Waycross Baptist Church lot known as the Owens place which J. V. Owens conveyed to Joel Ellison by deed bearing date February 15, 1906, and recorded in Deed Book SSS, page 7 in the said R. M. C. Office for Greenville County.
