


Geo. W. Webb, his heirs and assigns: All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, Located on the Northeastern side of old stage road (Now Maple Street) in the Town of Simpsonville, adjoining lands of the Estate of J. S. Moore, Maple Street, Jones Ave. and other property of Grantor, and being more fully described as follows:



Beginning at a corner in center of Old Stage Road, corner of lands of Estate of J. S. Moore, and running thence with the Moore Line N. 83 E. 179 ft. to iron pin; thence by new line N. 15-45 W. appx. 348 ft. more or less to point in center of Jones Ave.; thence with the center of Jones Ave. S. 79-30 W. 179 ft. to an iron pin in center of old stage road; thence with the old stage road, S. 15-45 E. 328.7 ft. to the beginning corner, and being the western portion of lot conveyed to Grantor under her maiden name, Zulieme R. Moore, by deed dated January 27, 1941 and recorded in the R.M. C. Office for Greenville County in Vol. 232, page 253.
