

That we, Paul Jennings and Dorothy Jennings, in the State aforesaid, in consideration of the sum of Thirteen Hundred Forty Five and no/100 (\$1345.00) DOLLARS, and the assumption of mortgage hereinafter more specifically set forth, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said W.. H. Sprouse and Cleo Sprouse, their heirs and assigns,

All that piece, parcel or tract of land in Greenville Township, Greenville County, State of South Carolina, near Saluda River, on northern side of a County Road leading northwesterly from the White Horse Road, being shown and designated as the southern portion of Tract Number Three (No. 3) on a plat and survey by J. Coke Smith, Sur., July 19, 1945, and, according to said plat, in part, having the following metes and bounds, to-wit:

BEGINNING at stake in said County Road, joint corner with the J. H.
McCollum land, and running thence with said McCollum line, N. 15-00 E. 20.81
