to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William Herbert Johnson, his heirs and assigns, forever:

All that lot of land with the improvements thereon situate on the Northwest side of Crosby Circle, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 8 on plat of Paramount Park, made by Piedmont Engineering Service, July 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "W", at page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Crosby Circle, at joint front corner of Lots 7 and 8, and running thence along the line of Lot 7, N 43-07 W 150.3 feet to an iron pin; thence N 46-45 E 35 feet to an iron pin; thence S 88-51 E 56.4 feet to an iron pin; thence along the line of Lot 9, S 43-15 E 110 feet to an iron pin on the Northwest side of Crosby Circle; thence along the Northwest side of Crosby Circle, S 46-45 W 75 feet to the beginning corner.
