to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Spurgeon Samuel Smith, his heirs and assigns, all that piece, parcel or lot of land in Gantt Township, within the corporate limits of Greenville, South Carolina, being known and designated as Lot No. 373, according to plut of Pleasant Valley Subdivision, prepared by Dalton & Neves in April 1946, as revised through September 1950 as recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, page 114, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Pacific Avenue at joint front corner Lots Nos. 373 and 372; thence S. 0-08 E. 160 feet to an iron pin at joint rear corner Lots Nos. 372 and 373; thence N. 89-52 E. 60 feet to an iron pin at joint rear corner Lots Nos. 373 and 374; thence along the joint line of said lots N. 0-08 W. 160 feet to an iron pin on the Southern side of Pacific Avenue at joint front corner Lots Nos. 373 and 374; thence along Pacific Avenue S. 89-52 W. 60 feet to an iron pin at joint front corner Lots Nos. 372 and 373, the point of beginning.
