

Curtis Porter in the State aforesaid, in consideration of the sum of -- Twelve Hundred and no/100---(\$1200.00)-----and the assumption of the mortgages hereinafter described, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joseph R. Leonard, heirs and assigns, forever: All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, lying and being on the Northwest side of Ridgeway Drive and being known and designated as Lot #73 of Woodfields, a subdivision located on the Southwest side of Augusta Road, as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book S, Page 7 (see also Plat Book S, page 139) and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Ridgeway Drive, joint front corner Lots 72 and 73 and running thence along Ridgeway Drive N. 44-09 É. 70 feet to an iron pin, joint front corner Lots 73 and 74; thence, with the joint line of Lots 73 and 74 N. 45-51 W. 214.9 feet to an iron pin, joint rear corner Lots 73 and 74; thence S. 42-45 W. 70 feet to an iron pin, joint rear corner Lots 72 and 73; thence with the joint line of Lots 72 and 73 S. 45-51 E. 213.3 feet to an iron pin on the Northwest side of Ridgeway Drive, the point of beginning.
