

and L. B. Aull as Executors under Will of J. A. Bull, Sr.

all that piece, parcel or lot of land in Chick Springs Township,

County, State of South Carolina on the East side of Saint Mark Road, and having  
according to a plat thereof made by H. S. Brockman, Surveyor, April  
10, 1944, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Saint Mark Road,  
corner of property now or formerly owned by Luther M. Coley, and  
running thence along the line of said property N. 66-10 E. 237.5 feet  
to iron pin; thence along the line of said Coley property S. 89-15  
E. 158.5 feet to iron pin; thence along the line of said Coley lot  
S. 67-00 E. 9.2 feet to iron pin, corner of said Coley lot and  
property now or formerly owned by Mrs. Lizzie Collins; thence along  
line of said Collins property and continuing along line of property  
now or formerly owned by Walter Smith, S. 67-00 E. 771 feet to a  
stake, corner of other property of J. A. Bull; thence along the line  
of said other property of J. A. Bull N. 12-45 E. 400 feet to a stake  
in gully and branch; thence continuing along line of said other Bull  
property and down said gully and branch as a line the following  
courses and distances; N. 55-20 E. 209.5 feet to a stake on the South  
bank of said gully, thence along said gully and branch N. 51-13 E.  
240.5 feet to a point in the mouth of a spring branch, thence along  
said branch S. 74-45 E. 150 feet to a stake in Lick Creek; thence  
with the meanderings of said Lick Creek along other property of J.  
A. Bull the following courses and distances: N. 34-10 W. 144.5  
feet to a point, thence N. 50-20 W. 106 feet to a point, thence N.  
5-45 W. 96.5 feet to a point, thence N. 30-10 W. 203 feet to a  
point, thence due N. 136 feet to a stake in said Lick Creek, corner  
of Property of J. A. Bull and property now or formerly owned by  
M. C. Ayers; thence along the line of said Ayers property S. 02-40  
W. 1511 feet to an iron pin by a Black Gum on the East side of said  
Saint Mark Road; thence along the East side of Said Saint Mark Road  
S. 13-30 E. 288 feet to a point; thence S. 23-00 E. 136 feet to iron  
pin on the East side of said Saint Mark Road, the beginning corner.
