

Campbell, his Heirs and Assigns forever, All those two certain pieces, parcels or lots of land in Chick String Township, Greenville County, State of South Carolina, situate on the Southeastern site of Luper-Highway No. 29, being shown as Lots Nos. 210 and 211 on Plat of the ir certy of hotert J. Edwards, made by Dalton & Neves in March 1951, and having according to ender Flat the following metes and bounds to-wit: BEGINNING at an iron oin on the Southeastern side of Super-Highway joint corner of Lots Nos. 211 and 212, and running thence with the line of Lot and 212 S. 47 E. 325 feet to an iron pin; thence S. 43 W. 200 feet to an iron pin at the rear a corner of Lot No. 209; thence with the line of said lot, N. 47 M. 325 feet to m. ircs pin on right-of-way of Super-Highway No. 29; thence with the Southeastern of the f Super-Highway No. 29, N. 43 E. 200 feet to the point of beginning.
