DEED OF TIMBER AND RIGHT-OF-WAY

KNOW ALL MEN BY THESE PRESENTS, That I, Necie E. Lockhart, of Tryon, North Carolina, in consideration of the sum of \$1000.00, to me in hand paid, at and before the signing of these presents, by the grantee, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain sell and release unto Gloucester Lumber Company, a corporation, and its successors and assigns forever:

"All merchantable timber except hickory, locust and walnut, as hereinafter defined, standing, lying and being on the following described property:

"All that tract of land in Glassy Mountain Township, Greenville County, South Carolina, on the Southern side of Hogback Mountain, and on the South side of Ballew's Mill Creek, containing 65½ acres, more or less, and according to a survey made by J. H. Adkins on January 6, 1911, is described as follows:

"BEGINNING at a large chestnut oak on Ballew's Mill Creek, and running thence S. 38-45 W. 23.40 chains to a chestnut oak near a large rock; thence S. 20-15 E. 7.50 chains to a big dead chestnut; thence N. 81-30 E. 15.30 chains to a chestnut oak at foot of rock boulder; thence S. 65-00 E. 8.40 chains to a hickory at top of cliff; thence N. 64-30 E. 21.80 chains to a blackgum on Ballew's Mill Creek; thence up Ballew's Mill Creek in a generally Northwesterly direction to the beginning corner."
