All that certain piece, parcel or lot of land situate, lying and being on the west side of Sherwood Street in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot #15 on Plat of Cleveland Terrace, made by Dalton & Neves, Engineers, Feb., 1926, recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book M, pages 142 and 143, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of Sherwood Street, joint front corner of Lots 45 and 46, and running thence with the line of Lot 46 S.87-33 W. 158 feet to iron pin on the East side of a 15-foot alley; thence with the said alley N. 5-38 E. 46 feet to iron pin; thence continuing with said alley N. 6-55 W. 49-9 feet to iron pin at rear corner of Lot 44; thence with the line of Lot 44 S. 85-38 E. 167.5 feet to iron pin on the West side of Sherwood Street; thence with the Vest side of Sherwood Street; thence with corner.
