BEGINNING at an iron pin on the Western side of McDaniel Avenue, which iron pin is 12 feet South of the joint front corner Lots Nos. 2 and 3 and running thence N. 75-31 W. 171.8 feet to an iron pin in the line of playground (which iron pin is 12 feet South of the joint rear corner Lots Nos. 2 and 3); thence along the line of the playground and the line of Lot No. 23 S. 14-29 W. 139 feet to an iron pin. joint rear corner Lots Nos. 1 and a lot marked "Sold"; thence along the joint line of said lots S. 73-31 E. 172 feet to an iron pin in the line of McDaniel Avenue; thence along the Western side of McDaniel Avenue N. 14-29 E. 148 feet to an iron pin, the point of beginning.

The grantee herein is to pay 1951 taxes on the above-described property.

The above property is sold subject to the following restrictions:

1. The property herein conveyed shall be used exclusively for residential purposes.

2. The front portion of any building to be constructed upon said property shall not be nearer than 40 feet to McDaniel Avenue.

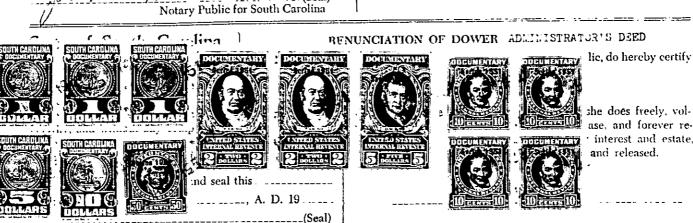
