- 4. Profits arising from the operation of the business are to be divided share and share alike, that is 2/5 thereof to C. B. Fields, 1/5 to Chester Jackson, 1/5 to T. W. White and 1/5 to John W. Jones, and all losses of the partnership if there be any, are to be borne by the partners in the same proportion. Settlement shall be had on Minday of each week for the business done the previous week, and the profits divided equally, or if there be losses from the operation of the previous week, the same shall be paid equally.
- 5. This partnership may be dissolved at any time by the mutual consent of the parties hereto. In the event that either of the partners desires to withdraw from the partnership, the remaining partners shall have the right to buy the interest of the partner withdrawing at a valuation to be fixed by the four partners.
- 6. This partnership is to continue from year to year unless terminated by mutual consent or death of the partners. One of the partners shall be selected as manager of the partnership each year.
