

presents do grant, bargain, sell and release unto the said. Walter F. Alewine, his heirs and assigns:

Lots 4, 5 and 6, described as a whole, have the following courses and distances as shown on said plat: BEGINNING at a point on wheatley Place, 65 feet from the intersection of wheatley Place and Gandy Street, being the joint corner of lots 6 and 7, and running thence along line of Lot No. 7 N 43-0 E 90 feet to joint corner of Lots 7 and 8; thence along line of Lot No. 8 N 3-01 E 39.2 feet to Lot No. 10; thence along the line of Lots 10 and 11 N 47-0 w 105 feet to joint corner of Lots 11 and 12; thence along the line of Lot No. 12 x 25-56 % 35 feet to joint corner of Lots 3 and 4; thence along the line of Lot No. 3 5 58-21 % 131.5 wheatley Place; thence with the northern side of street known as said street S 47-0 £ 175 feet to the beginning corner.

Lot No. 49 has the following course; and distances according to said plat: Beginning at a point on Tuskegee Avenue, joint corner of lots 49 and 50; thence along the line of Lot No. 50 S 24-15 E 110 feet to a point on the rear lot line of Lot Fo. 24; thence along the lines of lots 24 and 25 S 43-0 % 40 feet to joint corner of lots 25, 49 and 49; thence along the line of Lot No. 48 N 47-0 % 122.7 feet to Canly street; thence along Gandy Street N 55-18 E 85 feet to the beginning corner.

The property above described is conveyed subject to the covenants and restrictions recorded in the m.M.C. office for Creenville county in Deed Book 444, page 498, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, which is recorded in said m.M.C.
