

COURSES AND DISTANCES FOR LOT NO. 46: BEGINNING at a point on the western edge of a newly cut 36 foot street, joint corner of lots 45 and 46, and running thence S 63-30 W 200 feet to a point; thence S 26-15 E 100 feet to a point; thence N 63-30 E 200 feet to a point on the western edge of said newly cut street; thence along the western edge of said newly cut street, N 26-15 W 100 feet to the beginning corner.

COURSES AND DISTANCES FOR LOT NO. 49: BEGINNING At a point on the western edge of a newly cut 36 foot street, joint corner of lots 49 and 48, and running thence S 63-30 W 200 feet to a point; thence S 26-15 E 100 feet to a point; thence N 63-30 E 200 feet to a point on the western edge of said newly cut street: thence along the western edge of said newly cut street, N 26-15 W 100 feet to the beginning corner.
