of South Carolina, lying and being situate on the Southeast side of Knollwood Lane within the City of Greenville, South Carolina, being known and designated as Lot No. 130 and the Easterly and adjoining one half of Lot No. 129, Cleveland Forest, according to plat of said subdivision prepared by Dalton & neves, Engineers in Lay 1940, as revised September 1945, as recorded in the R. L. C. Office for Greenville County, South Carolina, in Plat Book II, page 137, and having, according to said plat, the following metes and bounds, to wit;

The above-described property is subject to restrictions recorded in the R. M. C. Office for Greenville County, South Carolina, in Volume k, pages 47 and 90. The said property is further restricted in that no residential building shall be built thereupon costing less than \$6,000.00 nor nearer than 50 feet to the street line. Any residential building built thereon shall face onto Knollwood Lane.
