

Ducker. in consideration of the sum of Fifteen Hundred and No/100 - (\$1,500.00) - - - - DOLLARS, and assumption of mortgage referred to below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Samuel F. Dilworth and Mary Alice Greer Dilworth, their heirs and assigns, forever:

All that certain piece, parcel or lot of land on the Northeast side of Old Buncombe Road, in Greenville Township, Greenville County, State of South Carolina, with the buildings and improvements thereon, being a portion of the property of Ethel Ayers as shown on plat made by W. J. Riddle, Surveyor, December 1947, and having the following metes and bounds, to-wit:
