

Taylor in the State aforesaid, in consideration of the sum of an exchange of a tract of land consisting of Chick Springs Township, valued at One Thousand (\$1,000.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. F. Roe and Ivey W. Roe, their heirs and assigns, all that piece, parcel, and lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Chick Springs Township, on the southwest side of a County road leading from the Super Highway to the Edwards road, and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint corner of tract Nos. 11 and 10 on the aforesaid county road according to plat of L. L. Richbourg property in Plat Book R. Page 65 and running thence S. 23-15 W. 475 feet to an iron pin; thence S. 65-0 W. 313 feet to an iron pin on the William Green line; thence S. 8-0 E. 305 feet to an iron pin; thence N. 40-0 E. 530 feet to an iron pin on the aforesaid County road; thence along said road S. 51-20 E. 222 feet to the point of beginning. The same containing 4.41 acres more or less, and being a portion of that tract of land conveyed to the grantor herein by A. M. Taylor and recorded in Vol. 303, Page 146 of Deeds in the R. M. C. office for Greenville County.

The grantee herein is to pay 1952 taxes.
