

to the grantor(s) in hand paid at and before the scaling of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John O. Mobley, his heirs and assigns:

ALL that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on Lenore Avenue, between the New Buncombe Road and Earnshaw Avenue, in Sans Souci Heights Subdivision, situate on New Buncombe Road about four miles North of the City of Greenville, said lot having the following lines, courses and distances, to-wit:

BEGINNING at an iron pin at the southern edge of a three foot sidewalk running along Lenore Avenue, said pin being the joint front corner of lots numbered 136 and 137; thence along the southern edge of said sidewalk, N. 58-50 E. 90.2 feet to an iron pin joint front comer of Lots Nos. 2 and 136; thence S. 39-10 E. 156.3 feet to an iron pin, rear corner of Lot No. 136; thence S. 53-32 W. 98 feet to an iron pin joint rear corner of Lots Nos. 136 and 137; thence with the eastern edge of Lot No. 137, N. 36-44 7. 164.3 feet to an iron pin, the beginning corner. Said lot being known and designated as Lot No. 136, as shown on plat recorded in Plat Book "Y" at page 145, in the R.M.C. Office.

It being the intention of the Grantor herein to convey the right to connect with the sewer line running across the rear of Lot No. 2 facing NewBuncombe Road.

The said above described property is subject to restrictions as recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 425 at page 500.


