

All that piece, parcel or lot of land with the improvements thereon situate, lying and being in Moraghan Wills Village, Greenville Jounty, South Jarclina, and being more particularly described as Lot No. 57, section 3, as shown or a plat entitled "Subdivision for Victor-Monagnan Mills, Greenville, S. J.," race by Pickell and Pickell, Engineers, Greenville, S. J., on Lecember 20, 1948, and recorded in the R.M.C. Office for Greenville Jounty in Flat Book "5" at pages 179-181, inclusive. BEGINNING at a pin on Donaldson Street, joint front corner of lots nos. 27 and 58 and running thence with Donaldson Street N. 79-30 3. 51. feet to a pin; thence running N. 34-17 W., 14.1 feet to a pin on Lobeth Street; thence running with McReth Street N. 10-30 E., 87.9 feet to a point on a 15 foot alley; thence running with said alley S. 79-26 L., 61.7 feet to a pin on said alley, joint rear corner of lots nos. 57 and 58; thence running with the line of lot no. 58 S. 10-41 W., 98.1 feet to a pin on Donaldson Street, joint front corner of lots nos. 57 and 58, which is the point of beginning; and reing the same property conto me by Elijan Stancil and Annie Lae S. Stancil by deed dated October 15, 1951, and recorded in the R.M.C. Office for Greenville Jounty in Deed Fook 445, page 419.
