

Know All Men by These Presents:

That I, James M. Henderson in the State aforesaid, in consideration of the sum of Sixteen Hundred Sixty-two and 50/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. Otto White, Jr., his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina situate, lying and being on the southeastern corner of Bellwood Drive and Holmes Drive in the City of Greenville and being known and designated as Lot No. 120 of Property of Central Development Corporation shown on plat thereof recorded in the R.S.C. Office for Greenville County in Plat Book "A", pages 148 and 149 and having according to said plat the following corners, to-wit:

BEGINNING at an iron pin on the southwestern side of Bellwood Drive at joint front corner of lots 120 and 121 and running thence along the southwestern side of Bellwood Drive N. 75-02 W. 75 feet to an iron pin; thence around the northern corner in a curved line, the chord of which is S. 70-18 W. 12.4 feet to an iron pin on the southeastern side of Holmes Drive; thence with the southeastern side of Holmes Drive S. 36-38 W. 41.1 feet to an iron pin; thence continuing with Holmes Drive S. 32-31 W. 94 feet to an iron pin on the joint corner of lots 119 and 120; thence with line of Lot 119 S. 72-59 E. 137.9 feet to an iron pin in the line of Lot 121; thence with the line of Lot 121 N. 20-20 E. 120 feet to the beginning corner.

The above described property is the same conveyed to me by Central Development Corporation by deed dated November 14, 1951 and recorded in the R.S.C. Office for Greenville County, Deed Book 445, page 531.

Grantee agrees to pay 1952 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
